On 6th May my home and family were visited by Paul Coleman from MASH. He was making an enquiry from a referral alleging emotional abuse of my daughters.

On 15th May we were again visited by Paul Coleman making an enquiry from a further separate referral. This time alleging physical abuse of my youngest daughter Pippa.

On 16th May we were required to have Pippa examined for abuse by the paediatric consultant at the children's wards in Hereford County Hospital. This was with a social worker present.

We have received no information or correspondence about any of this from your relevant departments or the management of Dilwyn playgroup who made the referrals.

This not knowing and nobody being willing to communicate with us is putting an intolerable strain on my family and myself.

This is not fair dealing.

I would very much appreciate being informed in writing where we stand on these issues and how you intend to proceed.

I would be grateful for a prompt response from you.



RE: COMPLAINT

My name is Wayne Calder and I am a Team Manager in the MASH Team of Herefordshire Children's Wellbeing Directorate.

I acknowledge receipt of your letter dated the 02/06/2015. In your letter you identified that:

- That a social worker, Paul Coleman, attended your home on the 06/05/2015 and the 15/05/2015 in regards to referrals that the department had received.
- You go onto say that a Child Protection medical was conducted on the 16/05/2015 with a social worker present.

I have now had an opportunity to review the case and can respond by clarifying that:

- The case initially came to the attention of the department when a referral was received from the nursery stating that Mrs McGeown was spoken to as she had expressed that she felt angry with a child and stated that she wanted to 'hit him'. It is recorded that that she did not hit him but she had told the manager that the thought was there. On further enquiries there was a record that Mrs McGeown had hit her own child in September 2014.
- On the 15/05/2015 further information was received from Pippa's school stating that Pippa had bruising to her arm and leg, there was no disclosure made by the child into how the bruising occurred so it was agreed between the parents and the social worker that the child would be taken to the GP.
- Our Emergency Duty Team (our team that works outside of normal office hours, i.e. evenings and weekends) conducted a s47 enquiry on the 15/05/2015 with the child CP medicaled on the 16/05/2015..
- The case has been transferred to our Child In Need (CIN) team for a more comprehensive assessment (referred to as a Core Assessment).

I do apologise on behalf of the department in regards to the length of time it has taken for the case to progress. The issue has been addressed with the relevant team and remedial action put in place to ensure that this situation does not happen again.

I hope that this response addresses the concerns that you raised.

I an contacting you as the most senior person from Herefordshire's Children's Wellbeing Directorate that has corresponded with us. I hope you can help us.

I have received some documentation about our case from Anthony Sawyer, Information Governance Officer as a result of making a subject access request. This is the first meaningful information that we have received.

This information contains a significant factual error in four separate records :-

Home Visit: Unannounced home visit undertaken 14/05/2015 at 12:35

In light of further information from Pippa's school who rang the MASH to express concerns that Pippa has bruising to her arm and leg when she went swimming with the school on 14/05/15, the case destination for this Initial assessment has changed from closure to a child in need plan.

I undertook a home visit to the address and initially only Jim (Father) was present. I informed him of the concerns. He was agitated and when Meg and Pippa subsequently arrived home he would not initially look at Pippa marks to her arm and leg. As there was no disclosure by Pippa that she was grabbed by her mother or father, this was not a section 47 enquiry. Pippa told me when alone that her friend in school grabbed her for the small bruises on her arms, or she may have caught her arm on the way into her Father's car and she was unsure as to how she occurred her bruises to the leg.

It was agreed that the parents would take Pippa for a non child protection medical to their local practice and Heather Manning from the MASH prioritised this appointment.

So the error :- "brusing discovered when swimming with the school on 14/05/15"?

Pippa is under 4 years old and does not attend a school.

She does attend a pre-school playgroup (offstead registered).

This playgroup operates $3^{1}/_{2}$ days a week (closed Wednesdays) in Dilwyn village hall. All activities take place within the environs of Dilwyn village hall.

They do not take the children to remote swimming lessons or any other instructional activities requiring undressing within or outside Dilwyn.

Pippa attends playgroup 7 hours Mondays, 7 hours Tuesdays and 4 hours Thursdays.

Pippa attended playgroup for the full 4 hours in the village hall on Thursday 14/05/15. I believe she was seen in the setting by one of your social workers around noon that day (I don't know the social workers name but she is a Muslim lady wearing a Hijab). Page 2 of letter dated 24/7/2015

We later found that what we thought was a social worker visit to playgroup on 14/05/2015 (Muslim lady wearing Hijab) was an unannounced visit by an OFSTED inspector to investigate their actions regarding their referral of us. http://www.reports.ofsted.gov.uk/inspection-reports/find-inspection-report/provider/ CARE/223516 Pippa is taken swimming on Wednesdays by her mother. This is at the HALO Leisure centre Leominster. The Leisure centre have public swim times for parents and children the rules of which require a parent to be with each pre-school child at all times.

This is a completely private visit with Pippa's mother being the only person changing, swimming with and drying/changing Pippa.

Dilwyn Playgroup is closed on a Wednesday and has no connection with Leominster swimming pool.

So I can not understand in any way the context of the referral recorded against us.

May I urge you to investigate and clarify the details of this reported incident. As the case was being put through for closure. This incident was the pivotal point between common sense prevailing and escalation to allegations of serious physical abuse.

Natural justice alone surely demands that this report is correct and accurate.

Can I appeal to you to help us with this issue or pass this letter on to the appropriate person who can.

Confirmation of receipt and action upon this letter would be very much appreciated.

Dear Mr McGeown,

I am writing in response to your letter dated 24 July, 2015 where you requested that an investigation was undertaken in regards to some information contained within the documentation that you had received that was factually incorrect.

I have now had the chance to review the case, and have also now spoken to Dilwyn Nursery. As a result of my investigation I can confirm the following:

• The nursery confirmed that they had noticed the injury to Pippa while she was attending the playgroup and this led to their referral to Herefordshire Children Wellbeing Service.

In the recordings it states that the injury was observed when Pippa had been taken swimming, following speaking with the nursery the circumstances surrounding how the injuries were discovered have been clarified.

I apologise on behalf of Herefordshire Children's Well-being Service for the factual error that the bruising was observed when the child was taken swimming. The bruising was, in fact, observed at the nursery.

I will append a note to the case record to ensure that it is recorded that the bruising was not found when the child was taken swimming and I will also address the accuracy of our recordings with our duty social workers.

I hope this resolves your issue.
